



WOODFIBRE LNG / FORTISBC SQUAMISH COMMUNITY OFFICE REOPENS

SQUAMISH, BC – Woodfibre LNG Limited and FortisBC are proud to announce the reopening of the Squamish Community Office at 38134 Cleveland Avenue in downtown Squamish.

The Squamish Community Office was temporarily closed on November 3, 2016 due to damage caused by a fire. No one was in the office at the time of the fire, and no one was injured. The incident is under investigation by the RCMP. No arrests have been made.

The Squamish Community Office first opened in November 2014 to offer Squamish residents a convenient location to ask questions about the Woodfibre LNG Project and the Eagle Mountain – Woodfibre Gas Pipeline (EGP) project.

About Woodfibre LNG Limited

The Woodfibre LNG Project is located approximately 7 km west-southwest of Squamish, British Columbia. It involves the construction and operation of a liquefied natural gas (LNG) export facility on the previous Woodfibre Pulp Mill site, which would have a storage capacity of 250,000 m³ and would produce approximately 2.1 million tonnes per year of LNG. Woodfibre LNG Limited is a privately held Canadian company based in Vancouver, and a subsidiary of Pacific Oil & Gas Limited, which is part of the Singapore-based RGE group of companies.
